Bikegeartracker collects the following data:

### [How do we collect your data?](#)

You provide Bikegeartracker with most of the data we collect. We have three main sources for data collection: manual input, Strava, and meteostat. We collect data and process data when you:

- Manually input data and submit this anywhere on the website with the use of the submit buttons
- Use the “Sync” option in the menu to be forwarded to Strava. Here you are asked to give permission to Bikegeartracker to access your stored data on Strava.

### How will we use your data?

Bikegeartracker collects your data so that we can:

- Provide you with a structured way of tracking your bike and its components over their lifetime;

### How do we store your data?

Our company securely stores your data at Versio BV using a mySQL database. Your connection to Bikegeartracker is secured with a Comodo PositiveSSL certificate, and your data is therefore securely sent for storage in the mySQL database.

Bikegeartracker will keep your user data for 1 year of non-activity (no new data collected). Once this time period has expired we will delete your data by removing all your entries you have ever made into our database.

### What are your data protection rights?

Bikegeartracker.cm would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request bikegeartracker.com for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that Bikegeartracker correct any information you believe is inaccurate. You also have the right to request Bikegeartracker to complete information you believe is incomplete.

**The right to erasures** – You have the right to request that Bikegeartracker erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Bikegeartracker restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Bikegeartracker’s processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Bikegeartracker transfer the data that we have collected to another organization, or directly to you, under certain conditions.
